### **2024 Summit Topic**

#### Al Horizons:

#### Navigate Taiwan's M&A and Tech Sector in the Age of Artificial Intelligence

The 2024 OIC Taipei Primary Market Summit demonstrated remarkable success in creating a comprehensive platform for talent development in Taiwan's primary market ecosystem. Bringing together 201 participants, including **25 distinguished speakers** and **176 attendees**, the event showcased an impressive depth of engagement across academic and professional domains.

The summit's strategic design featured a spotlight speech exploring Al's transformative impact, followed by Grand and Career Panels that delved into technological innovations and professional development. These sessions provided insights into emerging market trends, drawing participants from financial and banking backgrounds, with significant representation from international business, economics, and management disciplines.

A key highlight was the Social Event, which facilitated interactions between 20 industry professionals and students—this networking opportunity allowed for direct knowledge exchange, bridging academic learning with real-world industry perspectives. Participants represented a range of institutions, from top Taiwanese universities like National Taiwan University to international schools such as ESCP Business School and the National University of Singapore.

The event's comprehensive approach effectively addressed the complex landscape of primary markets, offering students a multifaceted understanding of career opportunities, and industry dynamics. By bringing together academic experts, industry leaders, and emerging talent, the summit created a unique ecosystem for learning, networking, and professional growth.

Biotech and semiconductors are leading this wave, with consumer goods sectors also showing strong growth potential.

Modern M&A creates unparalleled opportunities for financial professionals across diverse sectors—investment bankers structuring deals, PE/CVC professionals identifying acquisition targets, sell-side analysts providing critical market intelligence, and hedge fund managers monetizing on merger arbitrage opportunities.
